#### MARLBORO TOWNSHIP COUNCIL MEETING

March 7, 2019

Council President Metzger opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was sent to the Asbury Park Press, the Star Ledger, News Transcript and Board of Education Office on January 7, 2019; published in the Asbury Park Press on January 9, 2019; posted on the Bulletin Board of the Municipal Building; filed in the office of the Municipal Clerk and placed on the township website and Channel 77.

The Clerk called the Roll.

#### PRESENT:

Councilman Cantor, Councilwoman Marder. Councilman Scalea, Council Vice President Mazzola, and Council President Metzger.

Also present: Mayor Jonathan L. Hornik, Brian Trelease P. Esq., Business Administrator Jonathan Capp, Municipal Clerk Alida Manco and Deputy Municipal Clerk Suzanne Branagan.

Councilwoman Marder moved that the minutes of February 20, 2019 be adopted. This was seconded by Council President Metzger and passed on a roll call vote of 5-0 in favor.

Council Vice President Mazzola moved that the minutes of February 21, 2019 be adopted. This was seconded by Councilman Scalea and passed on a roll call vote of 4 - 0 in favor, with Councilwoman Marder abstaining.

## ORDINANCE # 2019-6

#### CALENDAR YEAR 2019

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Council of the Township of Marlboro in the County of Monmouth finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$295,753.10

in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of Marlboro in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Marlboro shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$1,035,135.83, and that the CY 2019 municipal budget for the Township of Marlboro be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

# RESOLUTION # 2019-111

RESOLUTION AUTHORIZING UNEXPENDED 2018 BALANCES BUDGETED FOR ACCUMULATED ABSENCES TO BE LAPSED INTO THE ACCUMULATED ABSENCE RESERVE PURSUANT TO NJAC 5:30-15

WHEREAS, NJAC 5:30-15 permits a local unit to establish a reserve for the payment of accumulated absences; and

WHEREAS, the Township of Marlboro has established a reserve for accumulated absences; and

WHEREAS, once an accumulated absence reserve is established, unexpended balances budgeted annually for compensated absences may be lapsed into the reserve; and

WHEREAS, it is recommended that the Township transfer \$50,000.00 to the accumulated absence reserve.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Marlboro that \$50,000.00 of unexpended 2018 budget appropriations for accumulated absences be transferred to the accumulated absence reserve.

## RESOLUTION # 2019-112

RESOLUTION AUTHORIZING UNEXPENDED 2018 BALANCES BUDGETED FOR SNOW REMOVAL TO BE LAPSED INTO THE SNOW REMOVAL RESERVE PURSUANT TO NJSA 40A:4-62.1

WHEREAS, NJSA 40A:4-62.1 permits a local unit to establish a snow removal reserve; and

WHEREAS, the Township of Marlboro has established a snow removal reserve; and

WHEREAS, once a snow removal reserve is established, unexpended balances budgeted annually for snow removal may be lapsed into the reserve; and

WHEREAS, due to the severity of the past several winter seasons, during which the Township utilized an extraordinary amount of de-icing agent to maintain the safety of the roadways, it is recommended that the Township transfer \$100,000.00 to the snow removal reserve.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Marlboro that \$100,000.00 of unexpended 2018

budget appropriations for snow removal be transferred to the snow removal reserve.

A RESOLUTION AUTHORIZING PARTICIPATION IN THE NEW JERSEY
E-PROCUREMENT PILOT PROGRAM, AUTHORIZING THE ENGAGEMENT
OF AN ON-LINE PURCHASING AGENT AND AUTHORIZING
INTERNET-BASED AUCTIONS AND EXECUTION OF AGREEMENTS
FOR THE SALE OF SOLAR RENEWABLE ENERGY CREDITS

WHEREAS, the Marlboro Township Municipal Utilities Authority (MTMUA) had a contract for the sale of solar renewable energy credits (S-RECs) which expired on May 31, 2011; and

WHEREAS, pursuant to provisions of the Local Unit Electronic Technology Pilot Program and Study Act (P. L. 2001, c. 30), local contracting units are specifically authorized to engage, without competitive bidding, on-line purchasing agents for the purpose of conducting internet-based auctions to procure certain bulk commodities, including S-RECs; and

WHEREAS, the Township has previously solicited proposals from three of the vendors authorized by the State of New Jersey to conduct internet-based auctions of S-RECs; and

WHEREAS, since 2012, the Township Council authorized the engagement of Marex Spectron, an on-line purchasing agent authorized by the State of New Jersey to conduct internet-based auctions for the sale of S-RECs generated or anticipated to be generated, at a reasonable sum of \$3.00 per S-REC; and

WHEREAS, the State of New Jersey allows local government units, through participation in an *E-Procurement Pilot Program* in accordance with the provisions of the *Local Unit Electronic Technology Pilot Program and Study Act* (P. L. 2001, c. 30), to utilize on-line auction services for the sale of S-RECs; and

WHEREAS, the Department of Public Works, Water Utility Division has recommended the selection of Marex Spectron to serve as Marlboro Township's on-line purchasing agent in accordance with its proposal.

WHEREAS, the Department of Public Works, Water Utility Division routinely monitors market conditions and advises that a sale of SRECs to be generated between June 1, 2019 and May 31, 2020, June 1, 2020 and May 31, 2021, and June 1, 2021 and May 31, 2022 may be beneficial at this time.

- NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Marlboro, County of Monmouth, and State of New Jersey, that:
- Section 1. The participation of Marlboro Township in the New Jersey *E-Procurement Pilot Program* pursuant to the provisions of the *Local Unit Electronic Technology Pilot Program and Study Act* (P. L. 2001, c. 30) is hereby authorized and approved for the sale of Solar Renewable Energy Credits utilizing on-line competitive bidding services and, in particular, an internet-based auction platform.
- Section 2. The Township is hereby authorized to enter into an agreement with Marex Spectron, with corporate offices located at 360 Madison Avenue, Third Floor, New York, NY 10017, as an on-line purchasing agent, to conduct competitive auctions utilizing an internet-based platform in conjunction with the Township's planned sale of S-RECs.
- Section 3. The engagement of Marex Spectron, shall be effected through the execution of an Agreement substantially in the form attached hereto and made a part hereof as Exhibit A, which said contract is hereby awarded, without competitive bidding, pursuant to the provisions of Section 7 of the Local Unit Electronic Technology Pilot Program and Study Act (P. L. 2001, c. 30).

## BE IT FURTHER RESOLVED that

- Section 1. The Mayor, or his designee, is hereby authorized to conduct internet-based auctions through Marex Spectron for the sale of up to the estimated 450 S-RECs to be generated between June 1, 2019 and May 31, 2020 and up to the estimated 900 S-RECs to be generated between June 1, 2020 and May 31, 2021, and up to estimated 900 S-RECs to be generated between June 1, 2021 and May 31, 2022; and
- Section 2. Funds in the amount of \$4,050.00 have been certified by the Chief Financial Officer in account \$#\$ 05-201-55-500-268030; and
- Section 3. The Mayor, or his designee, is hereby authorized to award a contract to and execute an agreement, in a form approved by the Township Attorney, with the responsible bidder(s) which offer(s) the highest per credit price offering resulting from the aforementioned internet-based auction for the

sale of S-RECs, provided the bid accepted offers a per S-REC price equal to or higher than \$210.00; and

Section 4. The Mayor, or his designee, shall report on the bid results at the first meeting of the Township Council following the conclusion of the auctions to enable the Township Council to ratify and confirm the contract award.

WHEREAS, the Township of Freehold and the Township of Marlboro are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Services Agreement pursuant to the Act; and

WHEREAS, the Township Council of the Township of Marlboro authorized the execution of a shared service agreement with Freehold Township on March 16, 2017 (R.2017-132) and entered into an Agreement whereby Freehold Township ("Freehold") provides Municipal Court Administration Services to the Township of Marlboro ("Marlboro"); and

WHEREAS, this cooperative Agreement has been beneficial to the taxpayers in both municipalities; and

WHEREAS, Freehold has agreed to continue the provision of Court Administration Services on an as-needed basis to Marlboro; and

WHEREAS, Freehold and Marlboro desire to renew a Shared Services Agreement to set forth the operational and financial terms concerning the work to be performed.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Township of Marlboro as follows:

- 1. The above recitals are hereby incorporated into the body of this Resolution as if set forth at length herein.
- 2. The Mayor and Township Clerk are hereby authorized to execute a Shared Services Agreement for Municipal Court Services.

AMENDING A SHARED SERVICES AGREEMENT WITH THE MARLBORO TOWNSHIP
BOARD OF EDUCATION PROVIDING FOR BUS TRANSPORTATION

WHEREAS, the Township of Marlboro ("Township") has requested and the Marlboro Township Board of Education (the "Board") has agreed to provide transportation services for the Township Youth Police Academy and Drug and Alcohol Alliance ("Alliance") programs; and

WHEREAS, pursuant to N.J.S.A. 18A:39-22, the Board is authorized to permit the use of school buses it owns or leases for the purpose of transporting children and adults participating in a recreation or other program operated by the municipality in which the Board's School District is located; and

WHEREAS, the Township and the Board desire to amend the Shared Services Agreement to provide Transportation Services for Youth Police Academy and Alliance programs for the period commencing on January 1, 2019 and terminating on December 31, 2019; and

WHEREAS, the costs of the Transportation Services for the Youth Police Academy and Alliance programs shall be paid by the Township to the Board as per the attached proposals in an amount not to exceed \$1,800.00; and

WHEREAS, N.J.S.A. 40A:65-1 et seq. authorizes local units to enter into shared services agreements for the provision of

services, including the transportation services contemplated herein; and

WHEREAS, the proposed Shared Services Agreement for the Transportation Services is on file in the Township Clerk's office in accordance with the provisions of N.J.S.A. 40A:65-5(b); and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in Current Account 01-201-25-106-288619 and Grant Accounts 02-213-18-721-135200 and 02-213-19-721-135200 in a total amount not to exceed \$1,800.00.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Marlboro, County of Monmouth, State of New Jersey, that the Mayor and Township Clerk are hereby authorized and directed to execute and witness, respectively, the proposed amendment to the Shared Services Agreement for the provision of transportation services for the Marlboro Youth Police Academy and Alliance programs in accordance with the term and conditions described hereinabove.

WHEREAS, on February 15, 2018 (R.2018-108) the Township

Council of the Township of Marlboro awarded contracts to GEORGE S. COYNE CHEMICAL CO. INC, KLENZOID INC., AND MAIN POOL & CHEMICAL CO. INC. FOR THE SUPPLY OF SPECIFIED CHEMICALS FOR THE TOWNSHIP OF MARLBORO DEPARTMENT OF PUBLIC WORKS WATER UTILITY DIVISION AND RECREATION AND SWIM UTILITY; and

WHEREAS, on November 29, 2018 (R.2018-341) and on February 21, 2019 the Township Council of the Township of Marlboro authorized a change order increases to the contract with Klenzoid Inc. in the amount of \$3,650.00 as a result of the additional materials required for the start-up and calibration of the new hardware and higher than estimated usage of the new Harbor Road Water Treatment Plant; and

WHEREAS, the bid specifications included the option to renew said contract for an additional one two-year, or two one-year extensions on the same terms and conditions at the exclusive option of the Township; and

WHEREAS, in a memo dated February 13, 2019, the Director of Public Works has recommended that the Township not renew contract 1B, for Hydrated Lime since it is no longer required, due to the completion of the new treatment facility at Harbor Road; and

WHEREAS, the Director of Public Works has also recommended that the Township approve a one (1) year renewal of each of the remaining chemical supply contracts including an increases to contracts 1C for Zinc Orthophosphate, 1D for Sodium Hypoclorite and 1E for Sodium Hydroxide to cover the needs of both the Tennent Road and Harbor Road Treatment facilities; and

WHEREAS, the Mayor and Township Council have indicated their desire to accept the recommendation as set forth herein; and

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Township Council of the Township of Marlboro, that Contract 1A be renewed with George S. Coyne Chemical Co., Inc. whose address is 3015 State Road, Croydon, PA 19021 for the Supply of Liquid Chlorine for the Township of Marlboro Water Utility Division, for a contract amount not to exceed \$22,340.25 and for a term of one (1) year beginning on April 1, 2019.

BE IT FURTHER RESOLVED by the Township Council of the Township of Marlboro, that a Contract 1C be renewed with Klenzoid Inc. whose address is 912 Spring Mill Avenue, Conshohocken, PA 19428 for the Supply of Zinc Orthophosphate for the Township of Marlboro Water Utility Division, for a contract amount not to exceed \$22,374.00 and for a term of one (1) year beginning on April 1, 2019.

BE IT FURTHER RESOLVED, by the Township Council of the Township of Marlboro, that Contract 1D, Contract 1E, and Contract

1F be renewed with Main Pool & Chemical Co. Inc. whose address is 110 Commerce Road, Dupont, PA 18641 for the Supply of Sodium Hypochlorite and Sodium Hydroxide, for the Township of Marlboro Water Utility Division, and for the supply of Sodium Hypochlorite, Sodium Bicarbonate, Calcium Chloride, and Sodium Thiosulfate for the Township of Marlboro Recreation and Swim Utility, for a contract amount not to exceed \$360,282.00 and for a term of one (1) year beginning on April 1, 2019.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute, and the Township Clerk to witness, Contracts with GEORGE S. COYNE CHEMICAL CO. INC, KLENZOID INC., AND MAIN POOL & CHEMICAL CO. INC. in accordance with this resolution, the bid specifications, and in a form to be approved by the Township Attorney.
