The Marlboro Township Council held its regularly scheduled meeting on April 11, 2019 at 7:00 P.M. at the Marlboro Municipal Complex, 1979 Township Drive, Marlboro, New Jersey.

Council President Metzger opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was sent to the Asbury Park Press, the Star Ledger, News Transcript and Board of Education Office on January 7, 2019; published in the Asbury Park Press on January 9, 2019; posted on the Bulletin Board of the Municipal Building; filed in the office of the Municipal Clerk and placed on the township website and Channel 77.

The Clerk called the Roll.

PRESENT:

Councilman Cantor, Councilwoman Marder, Council Vice President Mazzola and Council President Metzger. Councilman Scalea was absent.

AN ORDINANCE OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY, APPROPRIATING \$300,000 Α GRANT TO BERECEIVED BY THE TOWNSHIP FOR THE MARLBORO ROAD PROGRAM IN AND FOR THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW **JERSEY**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than a majority of all members thereof affirmatively concurring), AS FOLLOWS:

- Section 1. The \$300,000 grant expected to be received by the Township from the State of New Jersey Department of Transportation FY 2019 Municipal Aid Program is hereby appropriated for the purpose of providing funds for the Marlboro Road Program, including all work and materials necessary therefor and incidental thereto.
- Section 2. The capital budget or temporary capital budget, as applicable, of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Township Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect in accordance with law.

RESOLUTION # 2019-146

A RESOLUTION AUTHORIZING RENEWAL OF THE FRANCHISE AGREEMENT WITH NEW JERSEY NATURAL GAS COMPANY

WHEREAS, New Jersey Natural Gas Company has heretofore been granted a franchise and consent to lay, maintain and operate gas facilities in the Township of Marlboro; and

WHEREAS, New Jersey Natural Gas Company is desirous of obtaining a franchise and consent of the municipality to continue serving the municipality.

NOW, THEREFORE, BE IT RESOLVED, that New Jersey Natural Gas Company be and it is hereby authorized to lay, maintain and operate its conductors, mains, and pipes, together with the appurtenances thereto, in all the public streets, alleys, squares and public places in this municipality which are under the control and jurisdiction of the Township of Marlboro for the purpose of conducting gas, including natural gas, or any mixture of gases of various types and for the purpose of transmitting and distributing such gas in this municipality for a period of fifty (50) years from the date hereof, upon the following terms and conditions:

1. That New Jersey Natural Gas Company shall agree that, in all cases in which street openings or excavations are made for the purposes aforesaid that a permit will be obtained consistent with Chapter 326 of the Municipal Code of the Township of Marlboro entitled Streets and Sidewalks. Further, the pavement and surface of the

streets, alleys, squares or roadways shall be restored pursuant to the Township requirements; and

- 2. That New Jersey Natural Gas Company shall conduct the work or the laying or maintaining of gas pipes therein in a careful and prudent manner; and
- 3. That New Jersey Natural Gas Company shall safeguard the public interest in continuous and uninterrupted service at and after the expiration of the term of the grant; and
- 4. That New Jersey Natural Gas Company shall maintain its property in good order throughout the full term of the grant; and
- 5. That New Jersey Natural Gas Company shall continuously afford safe, adequate and proper service at just and reasonable rates.

BE IT FURTHER RESOLVED, that this franchise consent, upon approval of the Board of Public Utilities of the State of New Jersey, shall supersede the Resolution granted by the Township of Marlboro on April 8, 1969; and

BE IT FURTHER RESOLVED, that New Jersey Natural Gas Company shall file with the clerk of this municipality within sixty (60) days from the date hereof, its acceptance of the terms and provisions of the franchise consent herein granted and its agreement to be bound by the terms and provisions thereof; and

BE IT FURTHER RESOLVED, that this resolution shall not become effective unless and until it is approved by the Board of Public Utilities of the State of New Jersey.

RESOLUTION # 2019-147

A RESOLUTION AUTHORIZING CONSENT FOR ACCESS BY THE WESTERN MONMOUTH UTILITIES AUTHORITY (WMUA) AND CARBRO CONSTRUCTION TO BLOCK 225, LOT 229 LOCATED AT NEW JERSEY STATE HIGHWAY 79 SOUTH AND BUCK LANE TO FACILITATE COMPLETION OF PUMP STATION REHABILITATION PROJECT IN MARLBORO

WHEREAS, the Western Monmouth Utilities Authority (WMUA) has contracted with Carbro Construction ("Carbro") for the completion of a pump station rehabilitation project in Marlboro ("Project"); and

WHEREAS, the Township of Marlboro is the owner of record of a parcel located at NEW JERSEY STATE HIGHWAY 79 SOUTH AND BUCK LANE, also known as Block 225, Lot 229 as further identified and depicted in the attached Exhibit A ("Property"); and

WHEREAS, the WMUA and Carbro have requested right of access to the Property for the storage of equipment during the Project, between April 12, 2019 to October 1, 2019; and

WHEREAS, no disturbance to the Property is contemplated or anticipated under this agreement; and

WHEREAS, if for any reason the Property is disturbed as a result of any activities related to the project, the WMUA and Carbro will restore the Properties equivalent to pre-access condition; and

WHEREAS, WMUA and Carbro will ensure that the public has access to parking spaces on the Property at all times during the project; and

WHEREAS, the WMUA and Carbro will maintain the insurances required by the Township, and indemnify and hold the Township harmless from and against any and all claims arising out of the work contemplated under the agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Marlboro:

- 1. The Township, the owner of the Properties described above, consents to the WMUA and Carbro entering and having access to the Property for the purposes outlined above between April 12, 2019 and October 1, 2019.
- 2. The Mayor and Township Clerk are hereby authorized and directed to execute and witness, respectively, the Site Access Agreement in substantially the same form approved by the Township Attorney as that attached hereto and made a part hereof and any other documents which may be required or necessary to effectuate the Site Access Agreement.

RESOLUTION # 2019-148

A RESOLUTION OF THE TOWNSHIP OF MARLBORO IN MONMOUTH COUNTY, NEW JERSEY AUTHORIZING A SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF MARLBORO AND THE TOWNSHIP OF SHREWSBURY TO PROVIDE REQUIRED CYBER SECURITY TRAINING

WHEREAS, the Municipal Excess Liability Fund (MEL) and Monmouth County Joint Insurance Fund (JIF) have recommended cyber security training for municipal officials and employees due to the rise in cyber security breaches; and

WHEREAS, the Township of Marlboro has a contract with KnowBe4 for cyber security training; and

WHEREAS, KnowBe4 maintains a contract minimum which exceeds the number of users employed by the Township of Shrewsbury, precluding Shrewsbury from utilizing this service; and

WHEREAS, educating and training employees within the MEL JIF system ultimately reduces cyber risk and losses which benefits all of the members including the Township of Marlboro; and

WHEREAS, the Township of Marlboro has agreed to procure the number of KnowBe4 licenses required by the Township of Shrewsbury, and extend its pricing to the Township of Shrewsbury; and

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., (the "Act") permits units of local government to share services for particular purposes and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

WHEREAS, the Township of Shrewsbury and the Township of Marlboro are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Services Agreement pursuant to the Act.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Township of Marlboro as follows:

- 1. The above recitals are hereby incorporated into the body of this Resolution as if set forth at length herein.

WHEREAS, it is in the interest of the citizens of the Township of Marlboro, County of Monmouth and State of New Jersey to utilize the Joint Base McGuire-Dix-Lakehurst firearms practice range; and

WHEREAS, funds are available and have been certified by the Chief Financial Officer in the amount not to exceed \$2,500.00 for Operating Account \$01-201-25-106-288644\$; and

WHEREAS, the Township Council desires to approve the Chief of Police's recommendation to utilize the Joint Base McGuire-Dix-Lakehurst firearms practice range facility.

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that more than 14,500 lives were saved by seat belt usage nationally in the year 2016; and

WHEREAS, the State of New Jersey will participate in the nationwide "CLICK IT OR TICKET" seat belt mobilization from May 20 through June 2, 2019 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

WHEREAS, the Division of Highway Traffic Safety has set a goal of increasing the seat belt usage rate in the state from the current level of 94.47% to 100%; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways.

NOW THEREFORE, be it resolved that the Township of Marlboro declares its support for the "CLICK IT OR TICKET" seat belt mobilization both locally and nationally from May 20 through June 2, 2019 and pledges to increase awareness of the mobilization and the benefits of seat belt use.

WHEREAS, the Township of Marlboro advertised for the receipt of bids on February 13, 2019 for the provision of FOOD CONCESSION SERVICE AT THE MARLBORO SWIM CLUB FOR THE MARLBORO TOWNSHIP RECREATION AND SWIM UTILITY and received no responses; and

WHEREAS, on March 1, 2019 the Township of Marlboro advertised and solicited proposals pursuant to N.J.S.A. 40A:11-4.6 ("Competitive contracting proposal solicitation") for the FOOD CONCESSION SERVICE AT THE MARLBORO SWIM CLUB FOR THE MARLBORO TOWNSHIP RECREATION AND SWIM UTILITY; and

WHEREAS, on March 27, 2019 the Township received two (2) proposals for the provision of FOOD CONCESSION SERVICE AT THE MARLBORO SWIM CLUB FOR THE MARLBORO TOWNSHIP RECREATION AND SWIM UTILITY; and

WHEREAS, the Township Evaluation Committee, consisting of representatives from the Departments of Administration and Recreation reviewed the proposals; and

WHEREAS, in a memo dated April 5, 2019, the Evaluation Committee recommended the award of contract to All Around Concessions LLC to provide the FOOD CONCESSION SERVICE AT THE MARLBORO SWIM CLUB for the 2019 summer season, conditioned upon the contractor meeting the necessary proposal requirements prior to execution of the agreement; and

WHEREAS, the Mayor and Township Council have indicated their desire to accept the recommendation of the Evaluation Committee, and to award the contract as set forth herein.
